

**Sub: Approval of Locations for establishing new EMRS during 2020-21 – reg.**

Madam /Sir,

This is with reference to Letter No. 18015/15/2018 – Grants dated 21.01.20 wherein States were requested to identify suitable land for establishment of new EMRSs during 2020-21 in the Sub-Districts/Blocks as approved by CCEA and fulfils the criteria of having 50% or more tribal population and 20,000 or more tribal persons.


2. Based on the land details received, the approval of competent authority is accorded for establishment of EMRS in 57 locations as per the list at Annexure with the following conditions:

- a. The identified land shall be transferred in the name of the State EMRS Society / Tribal Welfare Department.
- b. The land should be demarcated appropriately and kept ready for handing over to the construction agency.
- c. The State Government will not undertake construction of schools in the approved locations. The Ministry has initiated the process of empanelling Construction Agencies to be entrusted with the construction work by following a due EoI process. Therefore the States are not required to start any construction work in the locations approved.
- d. The location of the Schools cannot be changed by the State Government unless approved by the Ministry.
- e. State Government will provide approach road access to the site along with the facility of drinking water etc. All the land development costs including levelling etc. has to be borne by the State Government.

3. The State Government/ State EMRS Society may identify alternate buildings for starting schools in the locations approved at the earliest and submit an action taken report to the Ministry in this regard.
